GENERAL PRICE LIST

1. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF: \$1695.00

The fee for our basic services constitutes a pro rata share of business expenses required to operate the mortuary, such as property taxes, licenses, utilities, insurance, maintenance of the facilities, motor equipment and staff readiness to serve the public regardless of their preferences, selections or type of dispositions, and will be added to the total cost of the funeral arrangement you select. This fee is already included in our charge for direct cremation, immediate burial, forwarding or receiving remains, this fee includes the recording of statistical information for the death certificate, procurement of the permit for disposition as required by cemeteries, common carriers, and or crematories, record retention and standard accounting procedures. Consultation and assistance in the planning and coordination of the funeral or memorial ceremony, recording of surviving relatives for obituary and clergy records, placement of newspaper notices (does not include newspaper charge); consultation with clergy, florist, selected cemetery, common carrier, and or crematory, completion of details for the services selected, including personnel for those selections, and advice concerning union, insurance or other eligible benefits to which the decedent may have been entitled.

3. PROFESSIONAL EMBALMING and CARE of REMAINS: \$475.00

Embalming: Except in certain special cases embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangement, such as a funeral with viewing. If you do not want embalming you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial.

- A. Dressing, Cosmetics, and Casketing (Professional hairdresser not included) \$195.00
- B. Refrigeration, in lieu of embalming (after 5 days, \$25.00 per day) \$160.00
- C. Dressing and Casketing only (un-embalmed) \$140.00

MINIMUM SERVICE ARRANGEMENTS

2. Minimal use of Facilities (Refrigeration included)
3. Local Transfer of Remains to Evergreen Crematory, located at Manni Funeral Home
4. Transportation of Remains to local cemetery

NOT INCLUDED, unless noted, are charges for professional embalming, dressing, cosmetics, viewing or visitation, funeral or memorial service, cash advances, etc. these and other services may be requested, or required, and applicable fees will be added. Please refer to the appropriate categories on the price list for respective additional charges.

Refrigeration of an un-embalmed body is required by state regulations after 24 hours (1223 (c), Article 3, Chapter 122, Title 16) the refrigeration fee is \$160.00 for first five days, thereafter \$25.00

18. PRICE FOR DIRECT CREMATION: **\$1615.00**
The crematory fee is NOT INCLUDED. The fee at Evergreen Crematory is: **\$350.00**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a cardboard box, fiberboard with inside & outside coverings, or hardwood caskets.
